About Us

The Child Growth Foundation (CGF) is a charity that improves the health and wellbeing of children affected by growth conditions caused by endocrine issues or congenital abnormalities. We do this by delivering information and support, by working with health professionals to improve awareness and patient outcomes and by funding research to raise understanding and provide better treatments.

To have a growth condition does not just mean extremely tall or short, it comes with a range of other symptoms including: curvature of the spine, learning difficulties, heart & kidney abnormalities, epilepsy and many other complications. Children will spend a great deal of their early life in and out of hospital and parents will spend a great deal of time filled with worry and loneliness.

For the child, and their families, affected by a growth condition the lack of support, combined with a lack of information and the isolation resulting from having a condition so few have heard of will mean a life of physical and emotional difficulties.

The CGF was founded in 1977 and for over 40 years has been helping to improve the lives of those living with growth conditions. We support around 1,500 families each year but there is so much more we could be doing.
